Danubian Studies Series is open to all researchers, academics and students that have an interest in the fields of applied or theoretical archaeology, history, political sciences, economics, geography, linguistics, or ethnography in/or in connection with this area.

The contributors should respect the profile and template of the volume for a better and faster processing of their articles.

English it is the only accepted language for the papers.

TEMPLATE

TITLE

The title of article will be followed by the name and surname of the author.

LIST OF AUTHORS

The author's address, affiliation and e-mail must be placed right-aligned at the end of the article. The authors must agree to insert their contact data. A list of authors will also be available on the website.

ABSTRACT

All the articles should include an abstract, which must not exceed 200 words and must contain the keywords.

KEYWORDS

Each article must be promoted by 6 keywords, chosen by author.

SECTIONS

For a clearer understanding, the articles should have sections numbered by Arabian numerals. Subsections may have two Arabian numerals followed by points.

LENGTH

Articles should not exceed 25 pages, including illustrations. Only in special cases may this rule be disregarded. Also, the articles must not be less than 10 pages.

MARGINS

The volume page has 297x210 mm, with empty borders of 25.4 mm. The font is Times New Roman of 11 points at 1.5 spaces.

CITATIONS

The citations must be inserted in the text, using abbreviations as in following example: (Buchi 1975, 159-160, pl. 55:1039, 1040)

BIBLIOGRAPHY

The bibliography will be at the end of the text in the following form:

Books

Buchi 1975 - E. Buchi, *Lucerne del Museo di Aquileia, I*, Aquileia, 1975.

Dyczek 2001 – P. Dyczek, *Roman Amphorae of the 1st–3rd centuries AD found on the Lower Danube. Typology*, Warszawa, 2001.

Articles

Benea 1990 – D. Benea, *Lampes romaines de Tibiscum*, in *Dacia*, XXXIV, Bucuresti, 1990, 139-167.

ILLUSTRATIONS

The illustrations must follow the text and have at least 300 dpi resolution. The files could be JPG, TIFF, and PSD.

The authors are kindly asked to respect the size of the volume page when they send illustrations.

EDITORIAL RULES

The Editorial Committee has the right to publish or reject any manuscript after a double peer reviewing procedure. The Peer Review processes are confidentially.

TERMS

The Authors, Editorial Committee and Peer Reviewers agree that until a decision of the Editorial Committee the publishing of articles is free of charge.

Also, nobody will receive compensation for articles, peer reviewing or other editorial activities. At the same time, they will be able to read all published articles in this volume, free of charge.

Special discount could be established with their institutions' libraries.

The Editorial Committee will be able to sell the volume to libraries and databases, and decide over the use of the received funds. Yearly, a financial report will be sent to Peer Reviewers and Authors.
